Sponsorship from BMI has helped with funds. 'Safeguarding' CET in October 2014 for DOs and optoms. ES is Clinical Lead for NE. Clinical Lead required for South. E-mail ES with any queries. Thank for votes in AOP elections.

## **Treasurers Report**

CLOC = Central Fund (benevolent and research). Voluntary Levy collected by LOC and sent on. SEE = children's charitable campaign run by Niall Dorgan (see below).

Accepted as correct (following change of dates for last year) Proposed Malkiat Singh, seconded by Bruce Evans.

Consider reducing levy again from 1.5% Statutory Levy to 1%. Officers think levy should be reduced and reserve should be spent. We have companies that want to sponsor our activity.

Half of one percent =  $\pounds$ 50k, one quarter of one percent =  $\pounds$ 25k.

Proposal to reduce by half of one percent by KR. Seconded by Bruce Evans. Majority vote to adopt. All present voted in favour of keeping the same accountant.

# **PEE Report**

Presented by Maggie Glover. Set up in 2008 but kept dormant. Resurrected last autumn. ES is Clinical Lead. Awarded NE GRR scheme in November. Went live in February 2014. Wrote leaflets. Payments made monthly. May payment pending. Collecting data electronically and manually and looking at targets. 20% expected to go into secondary care and it is higher in NE but running at national average. Looking at Enhanced Schemes in South Essex.

# Emma Spofforth: Saving Essex Eyes

Launch 17<sup>th</sup> September 2013 in Colchester. Media coverage on radio, newspapers, optical press, ITV Anglia News, newsletter to schools, Facebook, Twitter. Poster and information packs to 559 schools in September. Lesson plan for teachers and poster competition. Many practices supported campaign. Prize giving in Minories, Colchester. Winning poster designs to be distributed to opticians and GP practices in July.

## Constitutional amendment to adopt Officers at first meeting after AGM

Need to change wording of constitution. LOCSU say most LOCs appoint Officers this way. Proposed by Maggie Glover, seconded by Tim Dulley. All voted to change constitution.

## AOB

Badly written anonymous **letter from Southend Hospital** sent to practices saying referrals should be made on a certain fax number. Possibly arose because optoms had been using emergency fax number for non-urgent referrals. KL advised continuing to refer as normal using e-refer or via GPs. KL will liaise with Niral to resolve issue.

Lyn Price LEHN Chair: has sent newsletter. Most people present had received it. Advised her e-mail address lyn.price4@nhs.net Asked LOC to distribute newsletter and this was agreed. Looking to recruit to add to core group of ophthalmologists, CCG representation, optoms etc. First project is **child eyecare** 'Make every contact count'. Small poster to raise awareness of eye tests at 2 years old. Logo for optoms who are willing and able to see young children. Involve health visitors and school nurses. Small budget to fund project. Meeting 16<sup>th</sup> July in evening at Swift House, Chelmsford.

Second project: Falls affecting the elderly

Encouraged Contractors to have **nhs.net e-mail** account. Area Team needs nhs e-mails to issue alerts. ES said optoms might have to go through governance procedure to have an nhs e-mail.

**'Call to Action' National Eyecare Strategy**. Questionnaire going out to optoms via nhs.net and LOC, followed by meeting in mid August.
