



## GLAUCOMA REPEAT READINGS SCHEME – ENHANCED VERSION 2017

THIS NOW TAKES INTO ACCOUNT THE REVISED N.I.C.E.  
GUIDELINES 2017

### **Aims and objectives of service**

It is expected that the service will reduce the number of visits to the hospital eye service and reduce the likely waiting time for service users who will be able to access care in the local community.

The objectives of the service are to:

- Deliver high quality service user centred care in line with national standards and guidelines
- Reduce the inappropriate use of secondary care based ophthalmology services
- Deliver a cost effective service
- Improve relationships between the primary care optometrists, community and secondary care eye service.

### **Service description/care pathway**

Service users will be identified through a standard General Ophthalmic Services Eye examination, privately funded eye test or by their GP and have an IOP >23mmHg with NO other signs of glaucoma. These service users will be referred to the service through the appropriate referral route in accordance with the service user's registered GP (Appendix 2 indicates referral routes by CCG).

## Part 1

### First Assessment

The accredited practitioner for Glaucoma Repeat Readings will perform the following where necessary at the first assessment:

- Take the service user's medical history and symptoms to identify glaucoma risk factors.
- Take monocular distance visual acuity readings
- Check intra-ocular pressure measurement with (Goldman Applanation or Perkins Tonometry)
- Take an assessment of the Optic Nerve Head including CD ratio, comment on asymmetry and noting any other potential glaucomatous features
- Take Single Stimulus Suprathresholds Visual Fields measurement using a fields machine capable of printing

In accordance with the Glaucoma Repeat Readings pathway at Appendix 1, if the results of this assessment indicate:

- IOP  $\leq$  23mmHg with normal fields and optic disc appearance, the service user will be discharged back to the GP or referring community provider (plus pressure difference is less than 5mmHg between the 2 eyes.)
- Other patients with a pressure of 24 – 31mmHg or if pressures differ between the eyes by 5 mmHg or more then they should have a second contact IOP check on another occasion then need to proceed to Part 2 (2nd repeat IOP Assessment)  
IOP  $>$ 31mmHg, the service user will need to be referred to The Hospital Eye Service as an urgent case without a further repeat IOP check. Urgent referrals (those requiring an appointment within two weeks) should be faxed directly to the Hospital Eye Service using the **Urgent Fax number 01702 508174.**
- Any IOP with abnormal discs or any other pathology, the service user will need to be referred to the Hospital Eye Service.
- IOP  $\leq$  23mmHg with normal optic disc appearance but fields suspicious of glaucoma should proceed to second repeat Visual Field pathway. .

- IOP > 23mmHg with normal optic disc appearance but fields suspicious of glaucoma should proceed to Part 2 (2nd repeat IOP Assessment)
- other referable pathology, the service user will need to be referred to The Hospital Eye Service. This is only applicable if the patient is referred in from another practice and the provider is not familiar with the patient.

## Part 2

### 2<sup>nd</sup> Repeat IOP Assessment

Patient attends for repeat Goldman or Perkins Applanation tonometry on a **separate occasion**. I.e another day.

In accordance with the Glaucoma Repeat Readings pathway at Appendix 2, if the results of this assessment indicate:

- All patients with IOP > 23mmHg would be referred for OHT diagnosis.
- Where repeat applanation measurements show a consistent difference in pressure of 5mmHg or more, practitioners may wish to consider whether referral may be appropriate, or whether there is a reasonable explanation (e.g. surgery to one eye).
- The results are within normal limits the patient can be discharged. At risk groups should be monitored at appropriate intervals (i.e. Family History of Glaucoma).
- Where a patient has raised intraocular pressure and a suspicious visual field then the intraocular pressure would be refined in the first instance and if after refinement appears to be normal the visual fields maybe refined and can move to Part 2 (2<sup>nd</sup> Visual Field Assessment) . This will ensure that those that need referral after intra ocular pressure refinement do not go ahead and have visual field refinement unnecessarily.)

### **Repeat Visual field assessment where necessary.**

Patients who are identified as having suspicious visual fields during initial assessment will have visual fields repeated on a separate occasion assuming the optometrist is contracted to provide the service.

In accordance with the Glaucoma Repeat Readings pathway at Appendix 3, if the results of this assessment indicate:

- The results are within normal limits and the patient can be discharged. At risk groups should be monitored annually under GOS. (This would include the case where there is a defect on the repeat but NOT in the same areas of the visual field as the original defect. Such inconsistent defects are usually due to the patient finding the test difficult and should not, as a rule, lead to referral and further repeats/monitoring may well just add further confusion.)
- Visual field is suspicious and requires monitoring at appropriate intervals as identified by the optometrist and agreed with the patient
- Visual field defect is confirmed and the patient is referred to consultant ophthalmologist.

The Provider will be expected to adhere to the appropriate referral routes according to the Service user's registered CCG e.g. referral management services for any onward or recall referral and to report discharge. The appropriate route will be indicated by the commissioner.

Service user's results should be recorded in a safe retrieval system.

### **Location(s) of service delivery and Equipment**

The service shall be delivered from appropriate premises within the South Essex locality, in order to deliver the principles of 'care closer to home' and integration with other local services.

All participating Community Practices must be able to demonstrate that their premises meet the minimum requirements with regard to facilities and infection control as defined in the Quality In Optometry guidance for commissioned service.

They will also have the following equipment/facilities in workable order, fully calibrated in line with the manufacturer's guidance, and their practice and equipment will be available for inspection, if required.

- Goldman Probe/ Perkins type Applanation Tonometer
- Automated Visual Fields Machine capable of Suprathreshold and printing
- Visual acuity test chart
- Method for assessing Optic Nerve Head such as Direct Ophthalmoscope or Volk lens
- Appropriate medicines including Anaesthetic, Stain and methods for disinfecting probes, or disposable probes if used

- Telephone, Internet Connection and Fax.

### **Days/hours of operation**

As per hours stated in each practices' GOS Contract

### **Referral criteria and sources**

Service users who are identified as having IOPs over 23mmHg through the General Ophthalmic Service, Private eye examinations or GP, that meet the acceptance criteria, and are registered with a GP Practice that is a member of NHS Brentwood and Basildon, Castle Point and Rochford or Southend or Thurrock CCGs.

### **Referral processes**

- Service users will be identified through a standard GOS (General Ophthalmic Service) or private eye examination or by their GP. The health professional identifying the problem will refer the service user using an e-refer system, fax or NHS Mail through the appropriate referral route e.g. referral triage provider for the service user's registered GP as indicated by the respective CCG systems (Appendix 2 provides a list of referral triage providers by locality).
- If the referring person is an identified provider of the Glaucoma Repeat Readings service and the service user wishes their treatment to continue at the practice the provider can refer to themselves sending the referral form marked self-referral.

### **Communication processes**

- All service users will have outcomes recorded and reported to the GP and referring clinician. Where a referral management service is in operation, the outcomes will be reported through this system accordingly.
- If the service user receives onward referral to the Hospital Eye Service, the outcome should be reported back to the GP and the referrer. Where a referral management service is in operation, the outcomes will be reported through this system accordingly.

- Following receipt of a referral the community provider will be expected to make contact with the service user within 14 days of receipt. Reports and onwards referrals are expected up to 7 days from appointment.

### **Population covered**

Service users who are identified as having IOPs over 21mmHg through the General Ophthalmic Service, Private Eye Examination or GP that meet the acceptance criteria, and are registered with a GP Practice that is a member of NHS Brentwood and Basildon, Castle Point and Rochford or Southend or Thurrock CCGs ONLY.

### **Inclusion criteria includes:**

- Service user must be 18 years or older
- IOP >23 mmHg but <32mmHg
- Service user must have no other referable pathology
- No other signs of glaucoma such as ONH anomalies or or suspect angle closure glaucoma.
- Inconclusive visual fields tests for all IOPs below 32mmHg
- Service user must be registered with a GP Practice that is a member of either NHS Castle Point and Rochford or Southend or Thurrock CCGs.

### **Exclusion criteria includes:**

- Referrals relating to Children under the age of 18
- IOP >31 mmHg
- Concurrent referable pathology
- Visual fields suggestive of non glaucomatous causes
- Other signs of glaucoma such as ONH anomalies or Suspect angle closure glaucoma.
- Patients already under the glaucoma monitoring service
- Service user registered with an out of area GP.

The accredited practitioner must not have been removed from the register or have conditions been made on their registration by a fitness to practice committee or the licensing or regulatory body in the UK or in any other country or currently be under investigation.

### **Interdependence with other services/providers**

The service will be explicitly aware of the commissioned pathways. The service will work closely and in partnership with providers of primary, community and hospital based ophthalmic care.

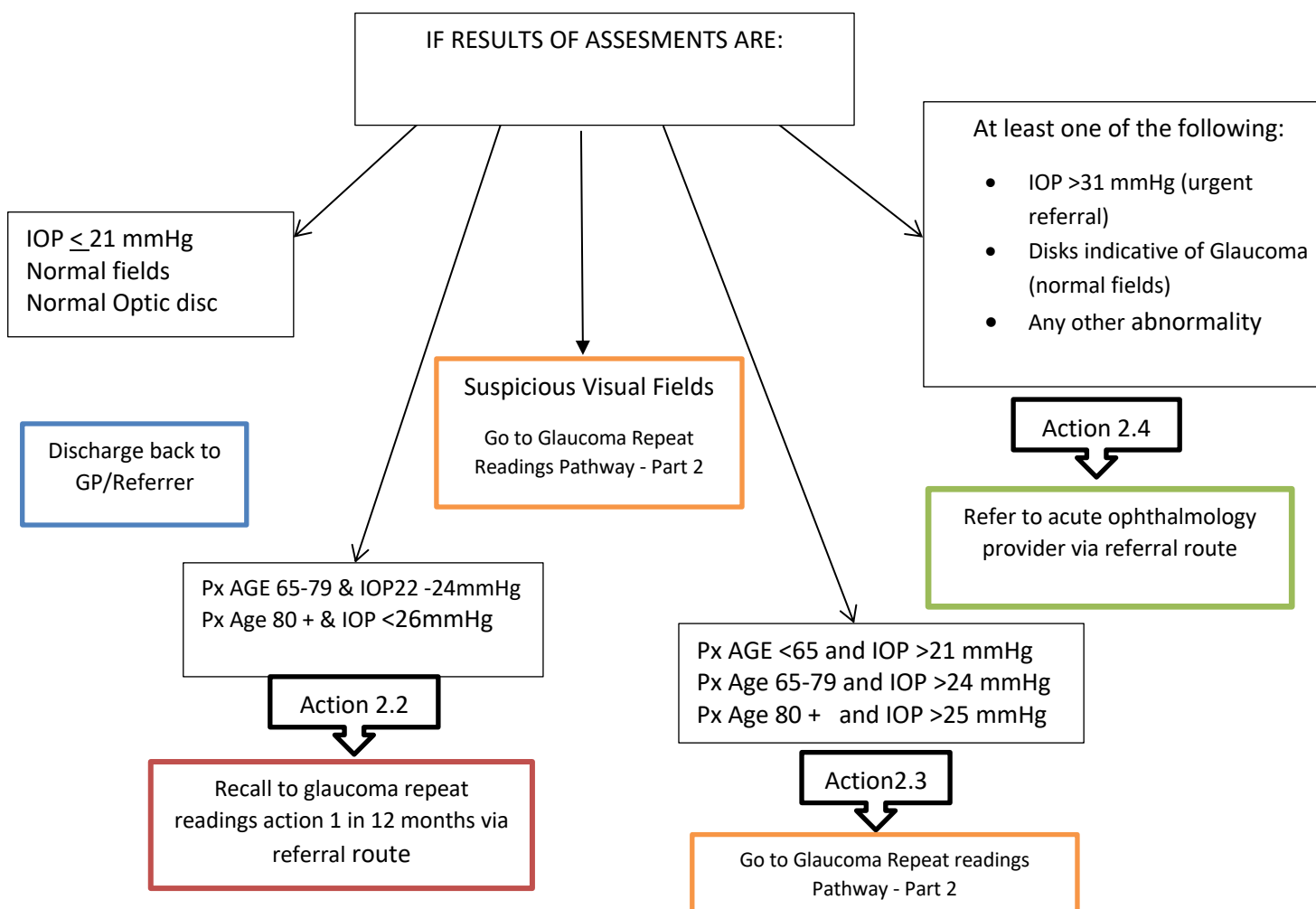

Refer Service user for Glaucoma Repeat Readings via appropriate referral route, e.g. Referral Management





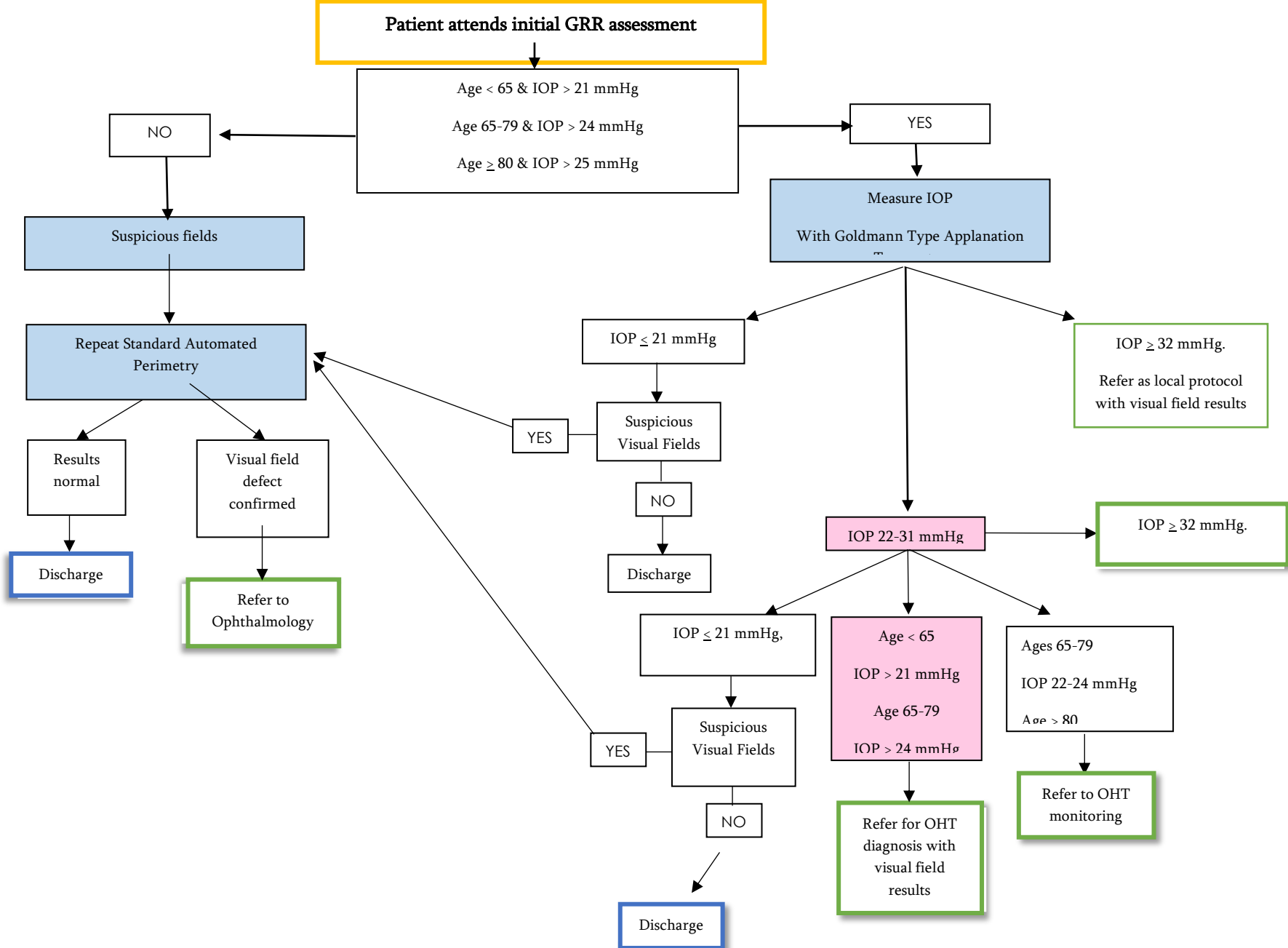

<b><u>Emergency Indications</u></b>	<b><u>Urgent Conditions</u></b>
<ul style="list-style-type: none"> <li>• Unexplained pre-retinal haemorrhage (diabetic patient with known proliferative retinopathy already actively treated in HES would not need an emergency referral);</li> <li>• Symptomatic retinal breaks and tears;</li> <li>• Retinal detachment unless longstanding and asymptomatic;</li> <li>• Scleritis;</li> <li>• Sudden severe ocular pain;</li> <li>• Suspected temporal arteritis;</li> <li>• Unexplained sudden loss of vision;</li> <li>• Uveitis;</li> <li>• Vitreous detachment symptoms with pigment in the vitreous;</li> <li>• Chemical injuries;</li> <li>• CRAO&lt;12 hours old;</li> <li>• Acute dacryocystitis, if severe or in children;</li> <li>• Acute glaucoma;</li> <li>• Hyphaema;</li> <li>• Hypopyon;</li> <li>• IOP <math>\geq</math> 45mmHg (independent of cause);</li> <li>• Sight threatening keratitis;</li> <li>• Orbital cellulitis;</li> <li>• Painful red eye after recent intraocular surgery eg cataract surgery</li> <li>• Papilloedema;</li> <li>• Penetrating injuries</li> </ul>	<ul style="list-style-type: none"> <li>• CMV and Candida retinitis;</li> <li>• Commotio retinae;</li> <li>• CRVO with elevated IOP;</li> <li>• Acute dacryoadenitis;</li> <li>• Disc haemorrhage (although a splinter haemorrhage in a patient with known glaucoma does not require urgent referral);</li> <li>• Sudden onset diplopia;</li> <li>• IOP&gt;35 mm Hg (and &lt;45mmHg) if the eye has no other signs of AACG;</li> <li>• Retinal detachment if not an emergency;</li> <li>• Retrobulbar/optic neuritis;</li> <li>• Rubeosis;</li> <li>• Suspect malignancies;</li> <li>• Suspect wet macular degeneration/choroidal neovascular membrane</li> </ul>
